When a Wake-Up Call Inspires a Legacy Gift

Ted Greene's love for Frankfort, Michigan, began in his childhood during summers spent on Crystal Lake. When school dismissed for the summer, Ted's parents would load up their car and drive the family over six hours from Shaker Heights, Ohio, to their Northern Michigan cottage. Year after year, those summer months were filled with sailing, golfing, tennis, and priceless family memories.

When the lot next to Ted's parents' cottage became available in the 1990s, he seized the opportunity to establish his own roots on Crystal Lake. Ted and his wife, Arline, built their primary residence there, ensuring the legacy of

family summers at Crystal Lake would continue. This deep-rooted love has been passed down to Ted's children and grandchildren, and soon, he hopes, to his great-grandchildren.

But Ted found his idyllic summers at the lake jeopardized when a medical emergency struck in 2023.

"I started to have some strange effects in my vision," shared Ted. "I was getting double-vision and occasionally blind spots. One night, I woke up with the most awful headache I've ever experienced. It was like somebody had driven a hot nail in."

Ted, a retired physicist who built a successful career in biotechnology, knew he needed advanced care.

"I tried every kind of over-the-counter pain relief; nothing worked. Finally, I said to my son, 'Would you mind taking me over to the emergency department?'" said Ted.

Ted knew that Munson Healthcare Paul Oliver Memorial Hospital (POMH), his local community hospital, was where he wanted to receive care.

A Surprising Diagnosis

From the moment Ted arrived at POMH, he found himself in the hands of skillful employees who listened to his concerns.

Jennifer Singleton, MD, MBA, FACEP, was the physician on duty in the POMH Emergency Department on that fateful summer day. She ordered a CT scan and performed several tests before hypothesizing her diagnosis: Giant Cell Arteritis (GCA). Dr. Singleton prescribed pain medication and steroids and then referred Ted to an ophthalmologist for a biopsy.

Pathology results confirmed Dr. Singleton's initial diagnosis. Ted indeed had GCA, a condition that occurs when the blood vessels in a person's scalp, neck, and arms become inflamed and limit blood flow. While women are more likely to develop GCA than men, some research suggests men are more likely to experience blindness as a result.

Ted, unfamiliar with GCA before his diagnosis, found himself surprised by the seriousness of his condition. What started as a headache now had the power to alter his life forever.

"If you don't get it treated, you go blind," Ted shared. "Permanently blind, which was a wake-up call."

Because his diagnosis came quickly, Ted began treatment early enough to prevent any serious complications. Ted has since completed treatment and has not experienced a return of the disease.

More to It Than Luck

Ted considers himself lucky he received a timely and accurate diagnosis from Dr. Singleton. In truth, luck played only a small part in his story.

Life-changing care was available at Ted's community hospital when he needed it. This care was made possible due to the generosity of countless families, including one family Ted had known all his life.

When Ted left POMH that summer day, grappling with his new diagnosis, two names on the building caught his eye: Wally and Peggy Nelson.

The Nelsons, who gifted \$500,000 to POMH in 2021, were dear friends to the Greenses. Peggy grew up on Crystal Lake around the same time as Ted. She went on to marry Wally Nelson, and the couple grew their friendship with Ted and Arline through time spent at the Crystal Lake Yacht Club, Crystal Downs Country Club, and community events.

Ted had seen the Nelsons' names on a recognition plaque when he previously visited POMH for routine appointments and lab work, but after this encounter, he saw things in a new light. An idea started to form in Ted's mind: he wanted to give back to his local hospital and community, just as the Nelsons had done.

Ted began reviewing his finances and connected with the team at Munson Healthcare Foundations to solidify his plans. He chose to make a \$500,000 gift to POMH in gratitude for the care he received and in honor of his late wife, Arline, who also received care at POMH during her battle with breast cancer.

"Arline was very loved and is very much missed by the community," said Ted. "I thought it was appropriate."

Munson Healthcare Foundations and POMH held a dedication ceremony for Ted's gift on July 3, 2024, highlighting

the newest names on the side of the building: "Ted & Arline Greene," listed right next to their friends "Peggy & Wally Nelson."

Securing Care for Future Generations

Ted, who splits his time between Michigan, California, and Florida with his family, is proud to know his gift ensures great care is always close by at their summer home.

"We always need to have Paul Oliver, and it always needs to have good staff, good facilities, and good equipment," said Ted. "I can testify, having worked in medical technology. If the technology is there, people can take advantage of it, and you can get a quick diagnosis of problems."

Ted remains grateful that POMH was there in his time of need, and he hopes that future generations of his family will

continue to benefit from having access to strong local healthcare.

"When you have a big family and lots of kids, you sure as heck want a very good hospital within 15 minutes or so," said Ted. "And that's kind of what led to my donation. I hope that Paul Oliver will always be here. I hope Paul Oliver will be there for my great-grandkids."

Having a well-equipped local hospital is important, but Ted knows what matters most is a healthcare team's commitment to their community and their patients. Dr. Singleton demonstrated this by taking the time to understand Ted, his background, and his concerns and communicating with him in a way that made him an active participant in his own care.

"It's the people who you deal with at an institution that really make a difference," said Ted. "And I was lucky. I got the best one."

Ted's remarkable gift exemplifies philanthropy's profound impact on a community.

"Just as the Nelsons inspired Mr. Greene, we hope this donation will inspire others to join us in this important work to provide exceptional care to the communities we serve," said Debra Henderson, president of Munson Healthcare Foundations.

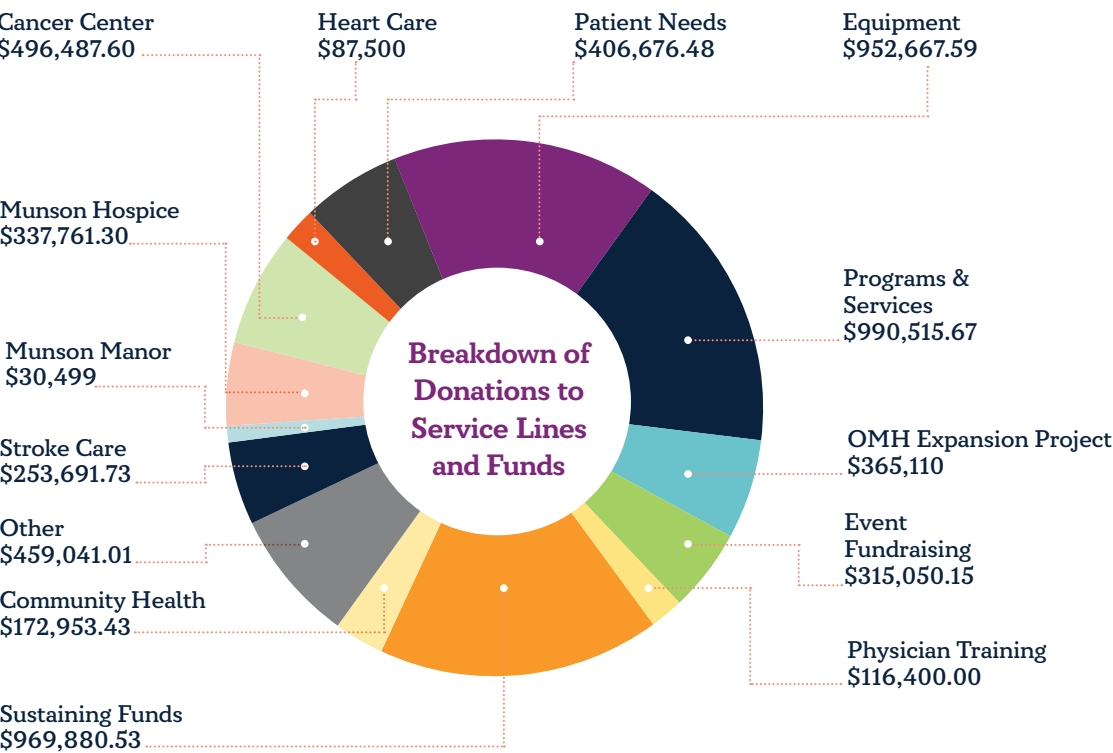
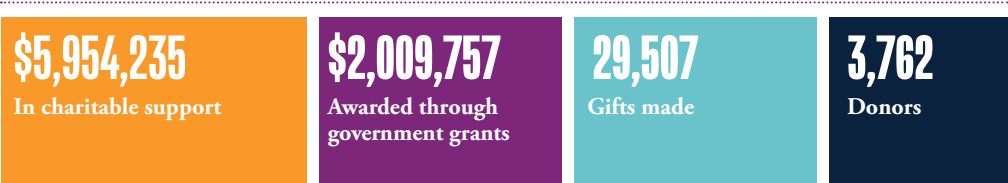

Calendar Year 2024 By the Numbers



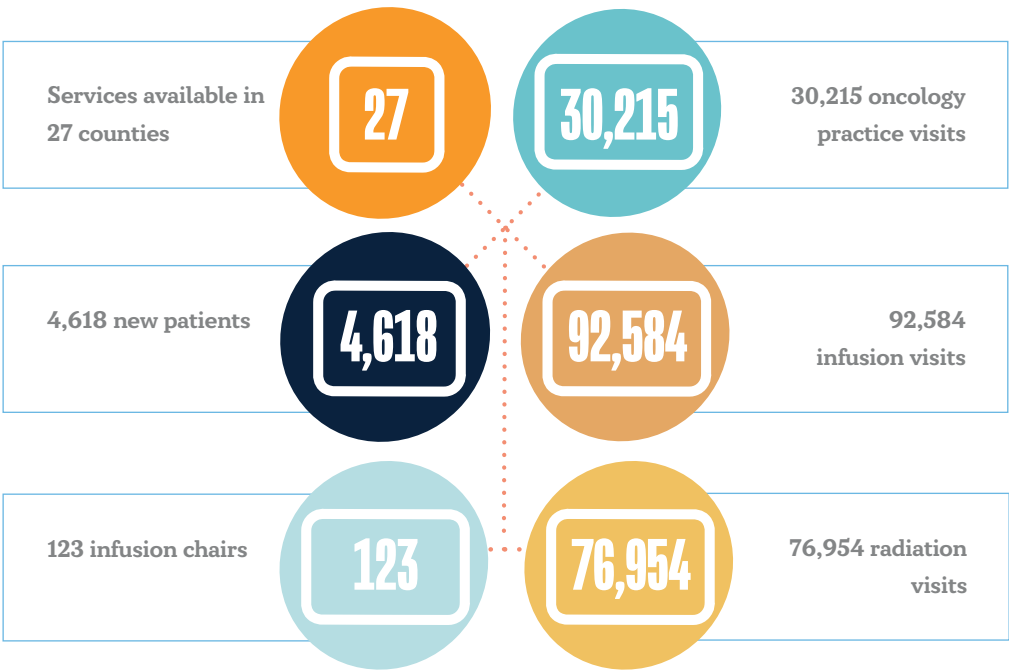

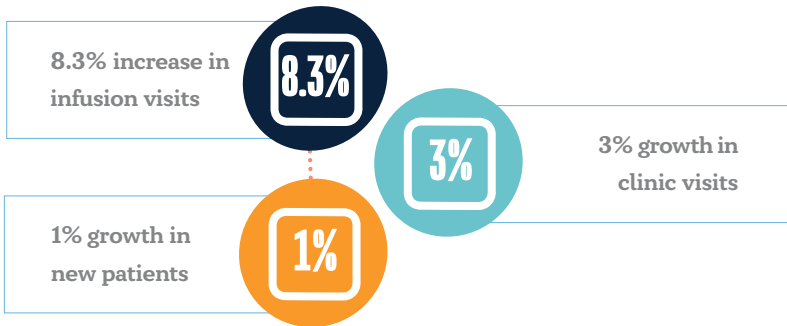
Coordinated Regional Cancer Care

Thanks to ongoing philanthropic support, Munson Healthcare is the proud home of world-class cardiovascular care in Northern Michigan. Here, our highly skilled team of medical professionals treat patients with the most innovative heart technology and equipment.

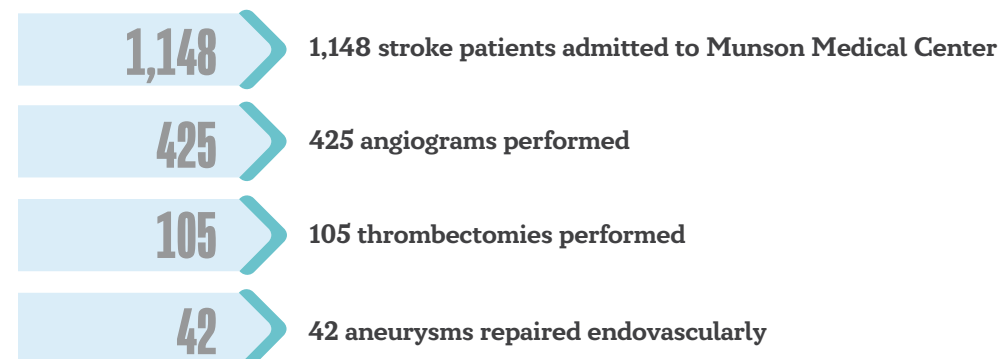

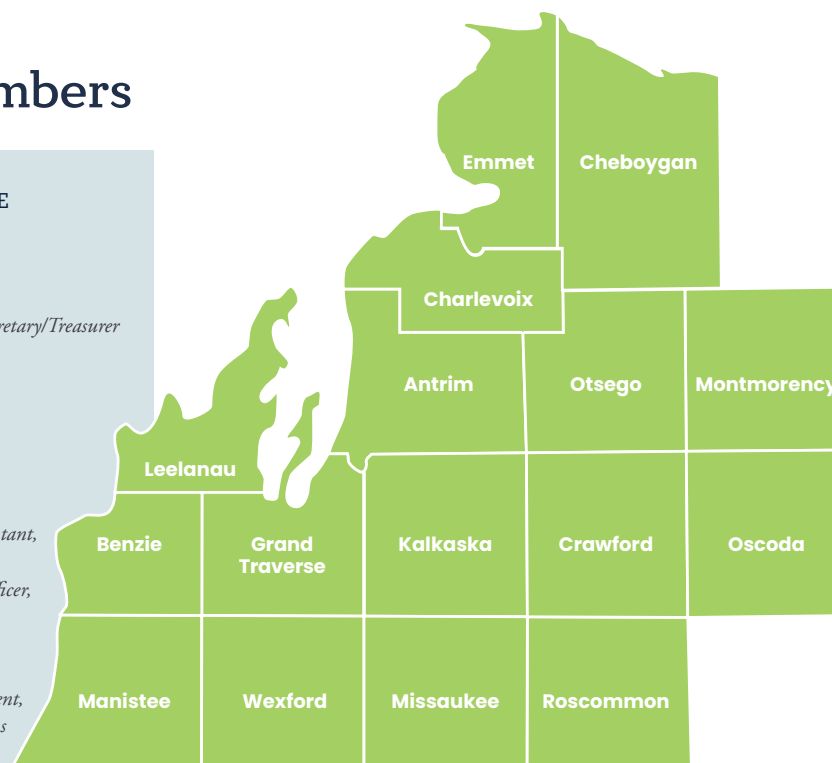
